**INTERNET SAFETY: WHAT YOU DON'T KNOW CAN HURT YOUR CHILD**  
(From the Office of the Texas Attorney General)

The proliferation of child predators using the Internet to target young victims has become a national crisis. A study shows that one in seven children will be solicited for sex online in the next year. Texas Attorney General Greg Abbott is urging all parents and teachers to realize the risks our children face online, and to do something to stop the predators before they target the innocence of more Texas children. Mr. Abbott is a national leader in tracking down and arresting online child predators. The Cyber Crimes Unit, launched by Abbott in May 2003, has arrested and obtained convictions of more than 100 predators who solicited sex online from persons they believed to be children as well as over 80 convictions of persons who possessed or distributed child pornography.
